WECSSO Executive Board Positions

The proposed new WECSSO Board of Directors has 12 Director Positions of Responsibility. Below is a description of each director's responsibilities.

- 1. President: Chair all meetings of the membership of WECSSO and of the Board of Directors
 - charged with the general management and supervision of the affairs and operations of WECSSO

2. <u>V.P. /Commissioner:</u>

- assume the duties of the President when the president is otherwise unavailable
- progress into the President's chair if, for any reason it is vacated during the term of office.
- handles the day-to-day operations of the summer Slo-Pitch League
- supervises the initial draft of players in each division and has the right to attend meetings called by conveners for their respective divisions
- assists the conveners in resolving disputes that arise during the season.
- has the authority to cancel games due to inclement weather. He will contact the conveners, UIC and the webmaster.
- is the contact person for NSA matters.
- 3. <u>Secretary:</u> record and distribute/email, facts and minutes of the meetings of the Board of Directors and AGM.
 - presents/reads minutes from previous meetings at all meetings and the AGM
- 4. <u>Treasurer:</u> receives all monies, and other available effects, of the organization and deposit same to the credit of WECSSO in a appropriate financial institution, as directed by the board
 - disperse funds under the direction of the board
 - keep accurate account of all receipts and disbursements in proper books of account.
 - presents a report at Board of Directors meetings and the AGM.

5. Bingo Cordinator:

- organizes a bingo committee to operate the bingos.
- contacts members and assigns duties require 2 booksellers, & cash payout person
- A signing Officer (Principle Officer, or Designated Member in Charge) must be present. Minimum of 3 must be present at all times.
- completes bingo reports for each session and a monthly report for the City
- applies for licences and attends Charity Association meetings
- 6. <u>Marketing Chairman:</u> sets up a committee to look at ways to promote (bring in new members) the summer Slo-Pitch league.

- 7. <u>Umpire-in-Chief</u>: organizes and supervises a system for the umpiring of all games Set up umpire clinics when needed
- 8. Convener: are 3 conveners, one for each division
 - conducts a draft with the managers to set up "balanced" teams
 - approves bats according to criteria set out by the Board of Directors
 - provide regular, up-dated standings for publication on the website.
 - conduct a supplementary draft(s) of players if needed to re-balance the teams.
 - meets with managers prior to the playoffs review rule of play and to address any concerns
 - meets with the managers to look at the ratings of players for next season
- 9. <u>Scheduler:</u> puts together a master schedule for team play for entire year, including playoffs for all 3 divisions
 - key dates for Opening Day, Appreciation Day, Remembranec Day, Annual Banquet and AGM are to be included in the schedule
 - updates rule changes as determined by the executive
- 10. <u>Social Director:</u> organizes Appreciation Day and Annual banquet
 - sets up a committee to help run the events
 - schedule and hire performers if wanted at the activities.
